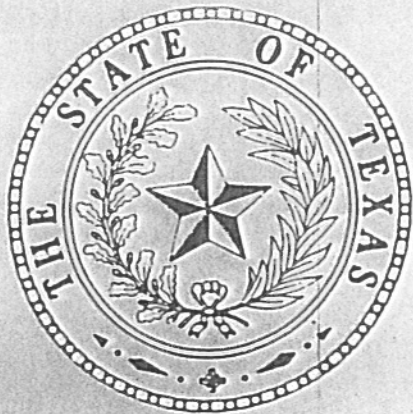

ARTICLES OF INCORPORATION

I, the undersigned natural person of the age eighteen years, or more, and a citizen of the State of Texas, acting as incorporator of a corporation under the Texas Business Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

Article One

The name of the corporation is Ranger Economic Development Corporation.

Article Two

The period of its duration is perpetual.

Article Three

This corporation shall be operated as a non-profit corporation, specifically governed by Section 4A of The Texas Development Corporation Act of 1979, as amended. (Tex. Ann. Civ. St. art 5190.6)

Article Four

The purpose of the corporation is to oversee and administer the revenue created by the sales and use tax, thereby to promote, assist and enhance economic development in and for the City of Ranger, Texas.

Article Five

The address of its initial registered office is 400 W. Main Street, Ranger, Texas 76470, and the name of its registered agent at such address is Jeane B. Pruett.

Article Six

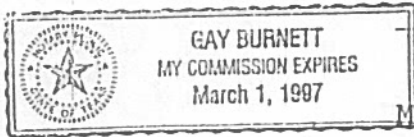
