

**RESOLUTION NO. 2024-02-08-C**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF RANGER, TEXAS, CANVASSING THE ELECTION RETURNS AND DECLARING THE RESULTS OF THE SPECIAL ELECTION OF THE CITY OF RANGER HELD ON SATURDAY, FEBRUARY 3, 2024, TO DETERMINE BY BALLOT PROPOSITIONS THE QUESTION OF REMOVAL OF TWO CITY COMMISSIONERS BY RECALL; AND DECLARING THE EFFECTIVE DATE OF THIS RESOLUTION.**

Whereas, pursuant to the Texas Election Code and the City Charter, the City Commission of the City of Ranger, Texas, convened on this the 8<sup>th</sup> day of February, 2024, for canvassing the vote in the special election held on February 3, 2024, to determine by ballot propositions the removal of two City Commissioners by recall;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF RANGER, TEXAS, THAT:**

**Section One. Canvass of Vote.** (a) There came to be considered the returns of the special election held on the 3<sup>rd</sup> day of February 2024, on the following ballot propositions:

**City of Ranger Proposition A:**

Shall Kevan Moize be removed from the office of City Commissioner by recall?

**City of Ranger Proposition B:**

Shall Samantha McGinnis be removed from the office of City Commissioner by recall?

(b). From the returns, the City Commission hereby finds that the following votes were cast in the election and that the propositions received the following votes:


the office of City Commissioner by recall. Commissioner Samantha McGinnis is hereby declared removed from the office of City Commissioner by recall.
