It shall be unlawful for any peddler or solicitor to engage in the business of peddling or soliciting within the city **between** the hours of **8:00 p.m.** and **8:00 a.m.** the following business morning, or at any time on **Sundays**.

The term "Peddler" shall mean and include any person who, without invitation, travels from door to door, and offers goods, services, wares, subscriptions, photographs, or other merchandise for sale, or any person engaging or engaged in the business of distributing Flyers, or advertising a commercial event, good or service.

The term "Solicitor" shall mean and include any person who, without invitation, travels from door to door and requests the donation of money, property, or anything of value, or the pledge of a future donation of money, property, or anything of value.

The application for a peddler permit to sell tangible goods or merchandise shall include with the application a bond in the penal sum of \$5,000.00, signed by the applicant and by some surety company authorized to do business in this state, conditioned for the final delivery of goods, wares, merchandise or services in accordance with the terms of any order obtained prior to delivery and also conditioned to indemnify any and all purchasers or customers for any and all defects in material or workmanship that may exist in the article sold by the principal of such bond, at the time of delivery, and that may be discovered by such purchaser or customer within 30 days after delivery. Such bond shall be for the use and benefit of all persons that may make any purchase or give any order to the principal on such bond, or to an agent or employee of such principal.

Any permit issued under the provisions of Ordinance No. 2013-07-08-4 may be revoked for the violation by the permittee or licensee of any provision of Ordinance No. 2013-07-08-4, state law or other ordinance that directly relates to the duties and responsibilities of the permittee or licensed occupation authorized in the permit. Upon such revocation, such permit shall immediately be surrendered to the authority that issued the permit, and failure to do so shall be deemed a misdemeanor.

PERMIT MAY NOT BE ISSUED EARLIER THAN 48 HOURS AFTER DATE OF REQUEST
